Since the products have already been bid at the national level, individual municipalities do not have to duplicate the bidding process per Equalis Contract #2020.05.2.

**Track Resurfacing:**

- Remove the existing track surface on the high jump area in the North D-area.
- Furnish and install our BSS 300 Sandwich track surfacing system with embedded texture in red over the high jump area at approximately 555 SY.
- Furnish and install our BSS 2000RE 5mm track resurfacing system in Red with Mid Grey exchange zones over the existing track surface on the track oval, Steeplechase, Long Jump runways, and PV runway at approximately 5,975 SY.

**Lump Sum Price for Work Stated Above: \$271,590.00**

**ADD Alternate No.1:**

- Furnish and Install our track surfacing in Mid Grey with Orange exchange zones for the following price added to the lump sum above: **\$23,256.00**

**If Bonding is required, please add 1.5% to the price above for performance payment and bonds.**

**This proposal includes the following:**

- Installation of surfacing per manufacturer's (Beynon Sports) specifications.
- Single mobilization; if the site is not ready and additional mobilizations are necessary, additional charges will apply.
- All lane lines and event markings.
- New or patched asphalt or concrete receiving surface be allowed to cure for 28 days depending on surface type.

**This proposal does not include:**

- Sales/Use tax.
- Prevailing/Union Wage Rates.
- Furnishing of Bonds or permits.
- Geotechnical investigation of the site.
- Relocation/removal of existing utilities.
- Protection of surface after completion.
- Painting of Logos or lettering.
- Design and construction documents.
