The Treasurer is also authorized to execute a notice of commencement to have on file in accordance with RC 1311.252.

<u>Section 5.</u> The Board of Education hereby authorizes the Authorized Representative (at a time determined appropriate by Authorized Representative), after the Authorized Representative's receipt of said Contract signed by the Contractor to forward a Notice to Proceed for said Contract.

<u>Section 6.</u> The Board of Education hereby finds and determines that all formal actions relative to the adoption of this resolution were taken in an open meeting of this Board of Education, and that all deliberations of this Board of Education and of its committees, if any, which resulted in formal action, were taken in meetings open to the public, in full compliance with applicable legal requirements, including Section 121.22, ORC.
